### **Terms and Conditions**

**TIMING:** The Boomerang Bucks Promotion ("Promotion") begins at 12:00:01 a.m. Pacific Time ("PT") on December 1, 2009 and ends at 11:59:59 p.m. PT on January 31, 2010 (the "Promotion Period"). Online Bill payments must be processed during the Promotion Period in order to be eligible. Bill payments processed after 11:59:59 p.m. PT on January 31, 2010 will not be eligible for this offer.
